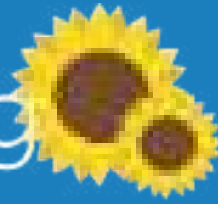

Social workers

Your **social worker** has a very important job, because they have to find out all about you and your favourite things, so that they can find a **foster family** who is the perfect match!

They introduce all of you and help you get to know each other, so you can settle into your new home. It is also their job to answer any questions you have - even if they're a bit difficult or you feel silly asking them.

The IRO is someone who will make sure that you are getting the best care possible. You can tell them anything and everything about being in foster care and how you feel.

They are there to understand how things are for you and they will always listen to you. They will also talk to other people, such as your social worker, parents/carers and others to find out how you are getting on in foster care.

If you have brothers and sisters in care, they will have the same Independent Reviewing Officer as you.

Foster families



Foster families and foster carers have the most important job of all. They are the people who look after us when we can't stay at home.

Sometimes they are married, sometimes they are not and some might even have children of their own - but not all of them do! All kinds of people can become **foster carers**, they can be any shape, colour or size - it doesn't matter, but they all have one thing in common - they love to help children like us!



Here are some of the things that they do:

They treat you as part of their family, even if they already have other children at their house, and they make you feel really important and looked after

They are great at listening

They care about you a lot, and want the best for you

They have lots of time to spare, and will make sure that they are always there for you

They have a bedroom in their house just for you

They make you feel safe and protected

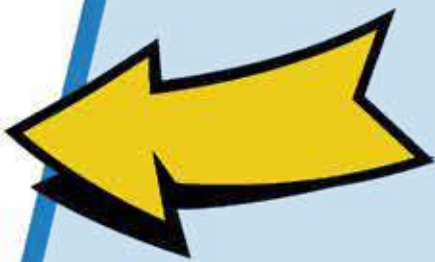
They will give you a nice warm, friendly home and all the things you need like food, clothes and stuff for school




Now that we have met the most important people here, let's find out what goes on!

I'm sure you have lots of questions - we did too, and we were really scared and confused at first, but our **social workers** and **foster families** were really helpful and explained it all to us

They helped us to understand why we couldn't live with our own parents. Everyone has different reasons, and some stay here for a little while, some for a long time, but everyone gets looked after and made to feel special for as long as they need.

Everyone that comes here gets given something called a 'care plan', and that's where everyone gets together and decides the best way to look after you. Please tell us what's important to help us care for you below:

What you can expect

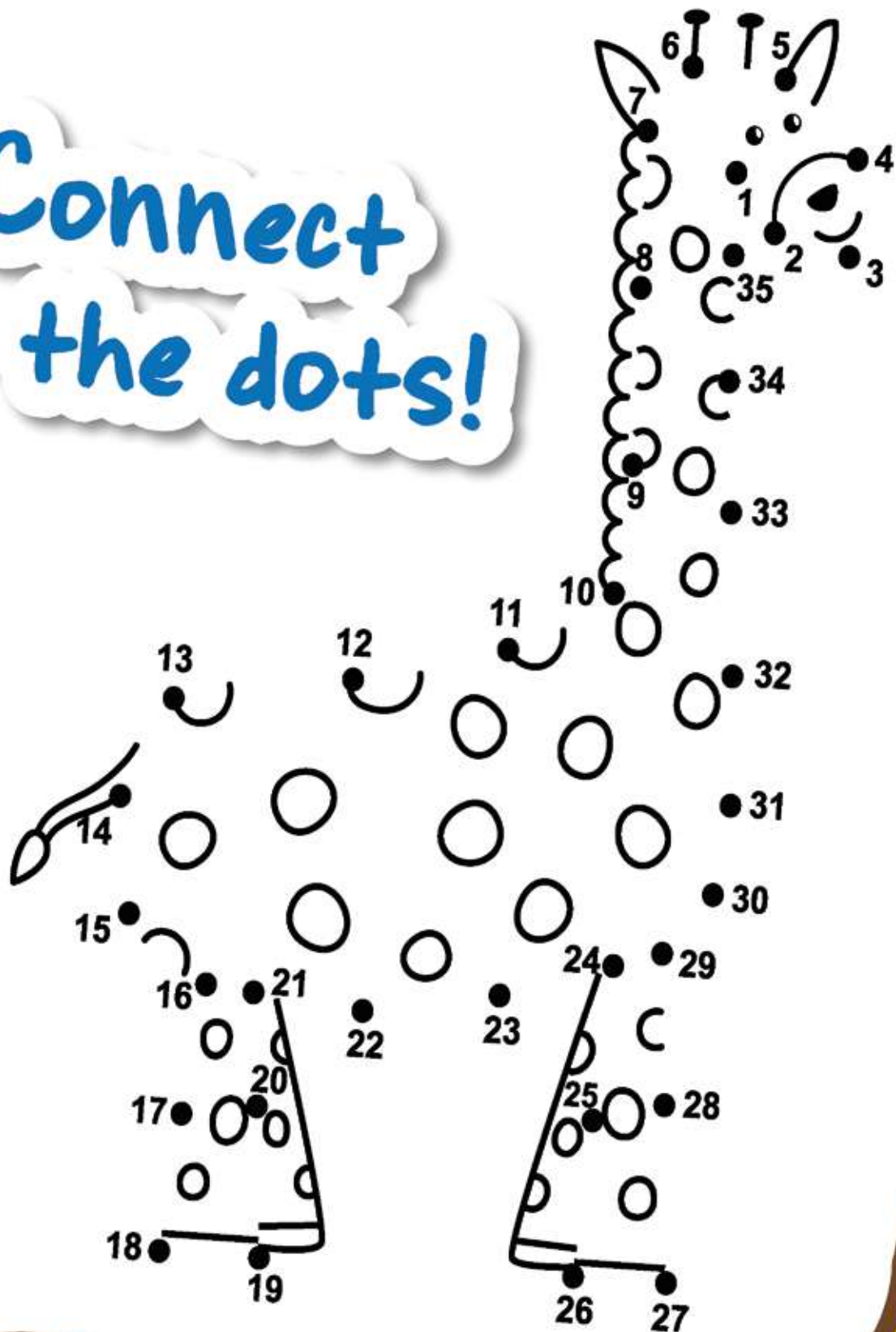


This part of the story tells you the things that you can expect from being in **foster care**.

- You have the right to a good standard of home life, which means that the house you live in should be comfortable
- You will be looked after properly, with things that you need such as nice food and clean clothes
- You can talk to your carer about any problems or worries that you have about school
- You get to see a doctor or a dentist whenever you need to
- Your wishes for your own family are respected and you can talk about any issues with your **foster carer** or **social worker**
- You have the right to think for yourself and have the right to tell people what you think
- You should be happy, comfortable and safe in your foster placement. If you are unhappy or unsure about anything you can speak to your **Excel Supervising Social Worker**, advocate or any other adult you trust
- You have the right to tell people your opinion, so if you have something to say or a question to ask, do not keep it to yourself - please speak out!



Connect the dots!



You might hear some pretty big words during your time in foster care, and just in case you don't want to ask anyone what they mean, you can have a look to see if they are here:

Dictionary

Advocate - Someone who can help children have their voice heard in meetings and support them if they have issues about their care.

Carers - Your parents, or other family members who look after you. Foster carers are people who are chosen by social services to look after you.

Children's Guardian - An independent person trained in social work, who works with children, young people, their families and others when there is a court case.

Confidential - Keeping a Confidence - Keeping something private. Your Solicitor can keep certain things you tell them private. Other professionals cannot agree to do this.

Foster Care - When a child is living with and being cared for by a family other than their own.

Foster Carers - These are the people who will look after you in their own home, with their families, providing you with shelter, food, help and care.

Foster Home - Where foster children live with their foster family.

Local Authority - The Local Authority is responsible for the local Social Services department and their Social Workers.



Looked After - A term used to refer to children and young people who are in the care of their Local Authority Social Services department.

Ofsted - A government agency that makes sure that foster care agencies are doing what they are supposed to in caring for children.

Parental Responsibility - The person or people with parental responsibility can make the important decisions about a child, such as - who they will live with, what school they will attend, and decisions about medical treatment. A local authority can get parental responsibility for a child under a Care Order but the parents will still have it too.

Social Worker / Social Services - A Social Worker is a person who has been trained to know about the welfare of children and families.

Wishes and Feelings - This phrase usually relates to the wishes and feelings of the child involved in the case in respect of who they want to live with, who they want to see and other wishes. The Children's Guardian must record the child's wishes and feelings in the guardian report. If a mature child disagrees with the recommendations made by the Children's Guardian then the solicitor must make sure the Judge or Magistrate know the young person's wishes and feelings and that there is a disagreement. Your views and wishes are very important to Excel Fostering and help us in providing good foster carers that will care and look after you.
